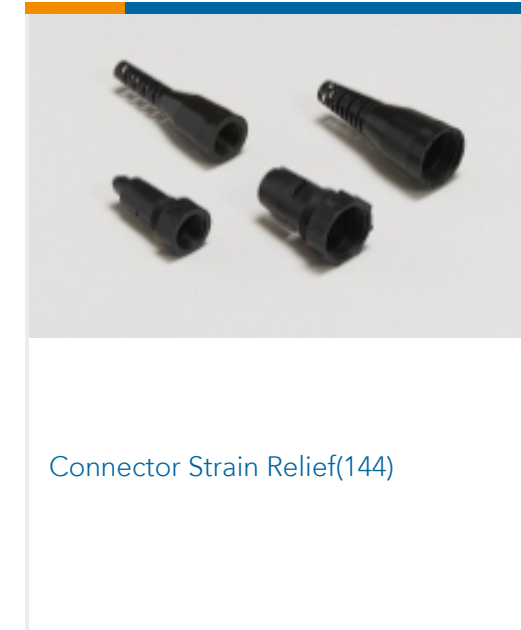
Connector Caps & Covers(3)



Connector Hardware(104)

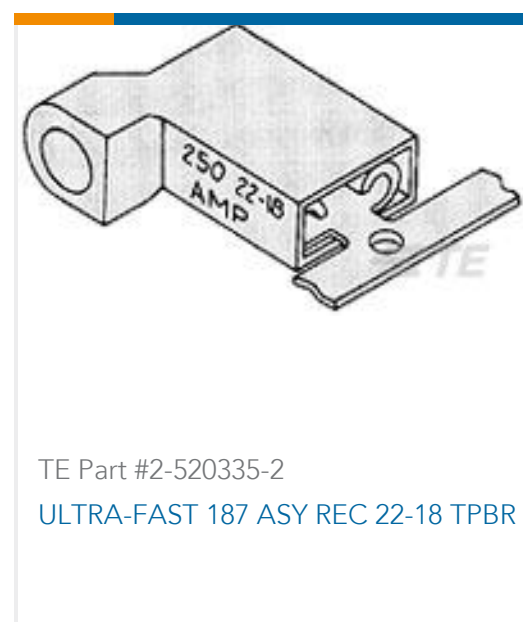


Connector Seals & Cavity Plugs(4)
